## Directory Introduction

This directory contains a list of Virginia Certified Nutrient Management Planners and businesses employing certified planners. The planners listed in this directory have responded to our questionnaire indicating they wanted to be listed as active plan writers. This directory does **not** list all the planners that are certified in Virginia, only those indicating that they wished to be listed in this document.

If you need a plan, check with your seed or fertilizer supplier(s) you deal with on a regular basis, as one resource for plan writing. A company could have a certified planner on their staff, which may not be listed in this directory, but would be more than willing to take care of any nutrient management planning needs you may have.

These Virginia Certified Nutrient Management Planners have met specific education and experience requirements, as well as having passed both parts of the Virginia Nutrient Management Examination. Meeting these requirements demonstrates a planner's knowledge and ability to competently write and help implement Nutrient Management Plans on farms in Virginia. The Department offers this directory for informational purposes only. Private certified planners are required to develop plans according to all Virginia Nutrient Management Training and Certification Regulations. However, we are not responsible for the way in which they conduct business.

There are two (2) categories of nutrient management certification: 1) Agriculture which deals primarily with traditional farming enterprises or, 2) Turf and Landscape which deals primarily with golf courses, lawns, athletic fields, public lands (parks, schools, community colleges, ornamental lands), commercial landscape (banks, office parks, church grounds), and other urban lands (common areas in gated communities, developments, and localities.) For your convenience, we have denoted on the attached list whether they are certified in agriculture, turf and landscape, or both.

Arrangements to have plans written, and discussion of fees for this service, should be made directly with the consultants or companies listed.
